1. Sweepstakes Period: Dreyer's Grand Ice Cream Sweepstakes ("Sweepstakes") begins June 16, 2022, at 12:00:00 a.m. Pacific Time ("PT") and ends July 3, 2022, at 11:59:59 p.m. PT ("Sweepstakes Period"). Sponsor is the official timekeeper for the Sweepstakes.

2. Eligibility: The Sweepstakes is open only to legal residents of the fifty (50) United States and D.C. who are 18 years of age or older at the time of entry (nineteen (19) or older if a resident of Alabama or Nebraska). A valid email address and internet access is required for entry. Employees, officers and directors of Sponsor, Universal City Development Partners, Ltd. d/b/a Universal Orlando Resort ("Universal Orlando"), Universal City Studios LLC d/b/a Universal Studios Hollywood ("Universal Studios Hollywood") (Universal Orlando and Universal Studios Hollywood may collectively be referred to as "Universal"), Promotion Activators Management, LLC ("Administrator"), Public Label Agency, and their respective parent companies, affiliates, subsidiaries, distributors, suppliers and advertising and promotion agencies associated with the Sweepstakes, and members of the immediate families (defined as including spouse, biological, adoptive and step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) or households (whether related or not) of any of the above are NOT eligible to participate in the Sweepstakes. Non-eligibility or non-compliance with any of these Official Rules may result in disqualification. Sweepstakes is void

outside of the 50 United States/D.C. and wherever prohibited by law. The Sweepstakes is subject to United States law.

4. How to Enter: Go to www.dgicvacationsweeps.com ("Website") and follow the on-screen instructions to complete the entry form in its entirety during the Sweepstakes Period to receive one (1) entry into the Sweepstakes.

Limit one (1) entry per person, per day, regardless of method of entry. For purposes of these Official Rules, a "day" is defined as beginning at 12:00 a.m. PT and ending at 11:59:59 p.m. PT. All entries received from any person that exceed the stated limitation will be disqualified. Entries made by any means which subvert the entry process will be void. Mass entries and entries generated by script, macro, or other automated means or by any means that subvert the entry process will be void. Incomplete or illegible entries will not be acknowledged. All entries become the exclusive property of Sponsor and will not be returned or acknowledged except as provided herein. In the event of a dispute as to who submitted an entry, the name of the "authorized account holder" associated with the email account will be deemed to be the entrant as long as such person is eligible and in compliance with these Official Rules. The authorized account holder of the email address is defined as the natural person who is assigned to the email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses or the domain associated with the submitted email address. Each potential winner may be required to show proof of being the authorized account holder. If a dispute cannot be resolved to Sponsor's satisfaction, the winning entrant may be deemed ineligible. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Sponsor will not verify receipt of entries. Proof of submission of an entry does not constitute proof of receipt by Sponsor. Released Parties (as defined in Rule 7, below) are not responsible for entries that are late, lost, illegible, damaged, misdirected, garbled or incomplete, altered or otherwise irregular, that contain false information, that are generated by script, macro or other automated or mechanical means, that have been submitted through illicit means or by any means which subvert the entry process or that do not conform with or satisfy any or all of the conditions set out in the Official Rules. **Multiple entrants are not permitted to share the same email address for purposes of entry into the Sweepstakes. 5. The Sweepstakes drawing will be conducted on or about July 10, 2022 (the "Drawing Date") by the Administrator whose decisions shall be final in all matters relating to the Sweepstakes. Two (2) potential winners will be selected at random from among all eligible entries received. Odds of winning a Sweepstakes prize will depend on the total number of eligible entries received. The entrants selected must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements and requests of Sponsor during the verification process.

7. Prizes and Prize Fair Market Values ("FMV"): Two (2) Grand Prizes will be awarded. Each Grand Prize winner ("Winner") will have the option to select to receive a trip to Universal Orlando Resort *or* Universal Studios Hollywood. Each Grand Prize winner will be awarded one (1) trip for winner and up to three (3) guests ("Guests(s)") to Winner's choice of Universal Orlando Resort in Orlando, Florida (the "UO Trip") or Universal Studios Hollywood in Los Angeles, California (the "USH Trip").

If the UO Trip is selected by the Winner, the Grand Prize has a Fair Market Value ("FMV") of Four Thousand Seventeen and 26/100 Dollars (\$4,017.26) (actual value may vary depending on departure date and location) and includes:

Binding Arbitration: Subject to applicable laws, any controversy or claim arising out of or relating to the Sweepstakes (excluding UO Trip Prize Claims and USH Trip Prize Claims described below) shall be settled by binding arbitration in a location determined by the arbitrator as set forth herein (provided that such location is reasonably convenient for claimant), or at such other location as may be mutually agreed upon by the parties, in accordance with the procedural rules for commercial disputes set forth in the Comprehensive Arbitration Rules and Procedures of JAMS ("JAMS Rules and Procedures") then prevailing, and judgment upon the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof. The arbitrator shall be selected pursuant to the JAMS Rules and Procedures. The arbitrator shall apply California law consistent with the Federal Arbitration Act and applicable statutes of limitations and shall honor claims of privilege recognized at law. If any part of this arbitration provision is deemed to be invalid, unenforceable, or illegal (other than that such claims will not be arbitrated on a class or representative basis), or otherwise conflicts with the rules and procedures established by JAMS, then the balance of this arbitration provision shall remain in effect and shall be construed in accordance with its terms as if the invalid, unenforceable, illegal, or conflicting provision were not contained herein. If, however, the portion that is deemed invalid, unenforceable, or illegal is that claims will not be arbitrated on a class or representative basis, then the entirety of this arbitration provision shall be null and void, and neither claimant nor Sponsor shall be entitled to arbitrate their dispute. Upon filing a demand for arbitration, all parties to such arbitration shall have the right of discovery, which discovery

shall be completed within sixty (60) days after the demand for arbitration is made, unless further extended by mutual agreement of the parties.

SUBJECT TO APPLICABLE LAWS, THE ARBITRATION OF DISPUTES PURSUANT TO THIS PARAGRAPH SHALL BE IN THE ENTRANT'S INDIVIDUAL CAPACITY AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE PROCEEDING. THE ARBITRATOR MAY NOT CONSOLIDATE OR JOIN THE CLAIMS OF OTHER PERSONS OR PARTIES WHO MAY BE SIMILARLY SITUATED. DO NOT ENTER THIS SWEEPSTAKES IF YOU DO NOT AGREE TO HAVE ANY CLAIM OR CONTROVERSY ARBITRATED IN ACCORDANCE WITH THESE OFFICIAL RULES. BY PARTICIPATING IN THE SWEEPSTAKES, EACH ENTRANT AGREES THAT TO THE EXTENT PERMITTED BY APPLICABLE LAW: (1) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE SWEEPSTAKES, OR THE PRIZE AWARDED, WILL BE RESOLVED INDIVIDUALLY THROUGH BINDING ARBITRATION AS SET FORTH ABOVE, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; (2) ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS WILL BE LIMITED TO ACTUAL THIRD-PARTY, OUT-OF-POCKET COSTS INCURRED (IF ANY), BUT IN NO EVENT WILL ATTORNEYS' FEES BE AWARDED OR RECOVERABLE; (3) TO THE EXTENT ALLOWED BY APPLICABLE LAW, ENTRANT WILL NOT BE PERMITTED TO OBTAIN ANY AWARD FOR, AND ENTRANT HEREBY KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, OTHER THAN ACTUAL OUT OF POCKET EXPENSES, AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (4) ENTRANT'S REMEDIES ARE LIMITED TO A CLAIM FOR MONETARY DAMAGES (IF ANY) AND ENTRANT IRREVOCABLY WAIVES ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW MANDATORY ARBITRATION, WAIVER OF CLASS ACTIONS, THE LIMITATION OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO RELEVANT PORTIONS OF THE ABOVE MAY NOT APPLY TO EVERY ENTRANT.

By entering, entrants agree that: (a) all issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrants' rights and obligations, and the rights and obligations of the Sponsor in connection with the Sweepstakes, will be governed by, and construed in accordance with, the laws of the State of California in the United States, without giving effect to any choice of law or conflict of law rules (whether of California or any other jurisdiction), that would cause the application of the laws of any jurisdiction other than California; and (b) any matters or proceedings which are not subject to arbitration as set forth above in this Section 8 of these Official Rules, and/or are related to

entering any judgment on an arbitration award, shall take place in the State of California in Alameda County.

Notwithstanding the foregoing, (1) any disputes, claims, and causes of action against Universal Orlando arising out of or relating to any person's use of, or participation in, the UO Trip itself ("UO Trip Prize Claims") shall be resolved by applying the laws of Florida, without regard to conflict of laws provisions therein, and shall be solely and exclusively brought in state or federal courts within Orange County, Florida; (2) any disputes, claims, and causes of action against Universal Studios Hollywood arising out of or relating to any person's use of, or participation in, the USH Trip itself ("USH Trip Prize Claims") shall be fully and finally adjudicated by binding arbitration to the fullest extent allowed by law (an "Arbitration") in Los Angeles, California and the Arbitration shall be administered by JAMS in accordance with the Streamlined Arbitration Rules and Procedure of JAMS (available at <https://www.jamsadr.com/rules-streamlined-arbitration/>) or subsequent versions thereof, including the optional appeal procedure; and (3) all such claims shall be resolved individually, without resort to any form of class action, and all such claims shall be limited to actual out-of-pocket costs incurred, but in no event to include attorneys' fees.
